

Constitution for Interwoven Productions

1. Name

The production activities of writer, JoJo Spinks, will be conducted under the name of **Interwoven Productions**. ("JoJo Spinks" is the name writing name of "Jo Spinks" or "Joanne Spinks", i.e. they are one and the same person). "Production" in this context means fundraising, venue booking, engaging and working with Associate Artists, rehearsal scheduling, marketing and promoting and all other administrative functions relating to the production of performance art.

2. Aims

The aims of Interwoven Productions are:-

- a) To create performance art that explores issues of interconnectedness – socially, environmentally, spiritually and historically.
 - i. To help communities in the South West of England to interpret, understand, enjoy and reconnect with their landscape heritage through art and performance.
- b) To encourage artistic collaboration that will enhance/facilitate the practice of artists and explore cross art-form performance.
- c) To champion a "Sacred" or "Gift" economy.

3.1 Associated Artists

Interwoven Productions seeks to collaborate with other artists. Individuals will be considered Associated Artists only when:-

- a) Artists have agreed to complete a "Project" within the aims and rules of the Constitution. A "Project" includes the development, rehearsal and evaluation of performance/s.
- b) Artists agree to volunteer their time and/or cap their remuneration in order to further the Aims of Interwoven Productions. The exact nature of the remuneration to be agreed at the outset of the Project.

3.2 Ceasing to be Associated Artists

Artists will be considered to have collaborated within the Constitution rules for the duration of a given "Project". The collaboration will automatically cease once the Project evaluation is complete.

Artists can cease to collaborate at any time by writing to JoJo Spinks.

4. Equal Opportunities

JoJo Spinks and Associated Artists will not discriminate on the grounds of gender, race, colour, ethnic or national origin, sexuality, disability, religious or political belief, marital status or age.

5. Business

The business of Interwoven Productions will be carried out by Jo Spinks who has responsibility for the maintenance and preparation of accounts:-

6. Finances

A bank account will be maintained on behalf of "Interwoven Productions" and held separate from all other accounts.

Records of income and expenditure will be maintained by Jo Spinks.

The income and property of Interwoven Productions shall be applied solely towards the promotion of the Aims of Interwoven Productions as set forth above. No portion thereof shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise howsoever by way of profit, to JoJo Spinks or Associated Artists. Provided that: nothing herein shall prevent the payment, in good faith, of reasonable and proper remuneration to any officer or servant of Interwoven Productions or to any Associated Artist, in return for any services actually rendered to Interwoven Productions.

7. Amendments to the Constitution

Amendments to the Constitution may only be made after one month's published notice.

8. Dissolution

If it is decided to dissolve Interwoven Productions all remaining money and other assets, once all Standing debts have been paid, will be donated to a local charitable Association.
